



24 hr rapid response to secure and protect 51 depots across the UK

SECURITY AND PROTECTION CHALLENGE

The company entered administration on Christmas Eve, and the news was widely reported across the media over the next few days. Apart from the difficult news for their staff, some media reports carried details that there were over 30,000 parcels still being stored at their depots.

SOLUTION

Recommendations for a range of security solutions were made and VPS SmartAlarms were installed at every site. The measures were backed up by warning signage to inform the public the site was being monitored, with regular reviews of the security levels and of any indications of attempted breaches.

These advanced alarms are stand-alone, and with a long-life battery so they do not require an external power source; they are only available through VPS, who designed and developed them in-house specifically for vacant properties. The VPS SmartAlarms communicate over the GSM network and do not require a phone line (like most fixed alarm systems do). The alarms are installed in tandem with wireless sensors, both internal and external, which communicate with the alarm unit. This provides instant detection and alerts on a range of incidents including intruders and flooding, allowing VPS monitoring station to facilitate rapid response to activations.

Vacant buildings and land are more vulnerable than occupied premises, and a prime target for unauthorised visitors such as vandals, trespassers, travellers and squatters. In all cases prevention is not only better than cure, but a far easier and more cost-effective option. VPS has built up a network of over 25 UK service centres from Glenrothes, north of Edinburgh, through to Exeter in the south.

Once the initial security operations were completed, the job didn't end there. The sites are monitored and reviewed to ensure the protection levels are meeting the requirements. VPS manage the access to the sites when required for the remaining activities in the administration process.
